The purpose of this modification is to increase the maximum ordering limitation of the contract by \$70,263 from \$2,217,785 to \$2,288,048. Accordingly, the following change is made:

1. Under Section B.4 "Consideration and Obligation--Task Orders (AUG 1989) Alternate I (JUN 1991)," paragraph a. is deleted in its entirety and the following new paragraph (a) is substituted in lieu thereof:

"(a) The maximum ordering limitation (MOL) for products and services ordered, delivered and accepted under this contract is \$2,288,048."

All other terms and conditions of this contract remain unchanged.
