Upon closer examination, it was determined that the 1D MSIV had closed, but that the 1A MSIV remained partially open. It was closed by licensee personnel 29 minutes later. The Unusual Event was terminated at 10:46 p.m. (CST), March 14, 1985. The unit had just successfully completed its Loss-of-Offsite-Power Test with the reactor shut down and offsite power restored when the incident occurred. While recovering from the test, the ESF signal was initiated due to low steam line pressure. The MSIVs were required to shut on this signal. In addition, the 1B Residual Heat Removal (RHR) pump failed to automatically start, and was manually started. The licensee has declared the two MSIVs and the RHR pump inoperable, and is taking the unit to cold shutdown while the failures are being evaluated. Region III (Chicago) is monitoring the licensee's corrective action. The State of Illinois will be notified. A Region III Resident Inspector and two region-based inspectors were present during the loss-of-offsite-power test and subsequent "unusual event."
