The Project Manager's briefing included acknowledgement of the issuance of the low power license for unit 1 on October 26, 1984, the licensee's expected readiness to be able to exceed the low power level, the FSAR related issues still under review, the status of the offsite emergency planning hearings and the FEMA review of the offsite emergency plans, the most recent SALP results and the licensee's organizational structure and operating shift status.

The licensee's presentation was based on the information provided in Enclosure 2. The meeting was concluded with the staff's observation that the information provided during the meeting was very responsive to the staff's request for a status update.

- INTERVENOR FILED EXCEPTIONS 10 DAYS LATER
- PECo AND MONTGOMERY COUNTY WATER AUTHORITY BRIEFS DUE FEBRUARY 4, 1985, THEN BUCKS COUNTY COURT WILL RULE
- APPEALS TO HIGHER COURTS ANTICIPATED
