This refers to the routine safety inspection conducted by Mr. I. Cohen of this office and other members of an NRC team on September 10-13, 1984, at the R. E. Ginna Nuclear Power Plant of activities authorized by NRC License No. DPR-18 and to the discussions of our findings held by Mr. Cohen with you and other members of your staff at the conclusion of the inspection.

The areas examined during this inspection were limited to observation of the Emergency Exercise conducted on September 12, 1984, and a review of the status of open items noted during previous inspections. Within these areas, the inspection consisted of selective examinations of procedures and representative records, interviews with personnel, and observations by the inspector.

Within the scope of this inspection, no violations were observed.

In accordance with 10 CFR 2.790(a), a copy of this letter and the enclosure will be placed in the NRC Public Document Room unless you notify this office by telephone, within ten days of the date of this letter and submit written application to withhold information contained therein within thirty days of the date of this letter. Such application must be consistent with the requirements of 2.790(b)(1). The telephone notification of your intent to request withholding, or any request for an extension of the 10-day period which you believe necessary, should be made to the Supervisor, Files, Mail and Records, USNRC, Region I, at (215) 337-5223.
