SUBJECT: PROPOSED CIVIL PENALTY ACTION: EA 84-59 (REPORT NOS. 50-321/84-18 AND 50-366/84-18)

A special safeguards inspection was conducted by members of the NRC Region II staff on May 30, 1984 of activities authorized by NRC Operating License Nos. DPR-57 and NPF-5 at the Hatch facility. The findings were discussed with Mr. J. T. Beckham, Jr., Vice President and General Manager, Nuclear Operations, Georgia Power Company, and Mr. H. C. Nix, Site General Manager, Plant Hatch, at an Enforcement Conference held in the Region II Office on May 31, 1984.

The purpose of this inspection was to evaluate the significance of the licensee's failure to control access to the protected area. On May 22, 1984, access to the protected area was not controlled in that the security officer assigned to conduct searches of hand-carried items of personnel entering the protected area failed to conduct an adequate search of an employee's purse. The inadequate search resulted in the undetected introduction of a small loaded weapon into the protected area. Failure to provide access control to a protected area is a violation of regulatory requirements. The violation and related NRC concerns were discussed during an Enforcement Conference.

The violation relating to the failure to control access to protected areas that is identified in the enclosed Notice of Violation and Proposed Imposition of Civil Penalty has been categorized in accordance with NRC Enforcement Policy, 10 CFR Part 2, Appendix C, as revised, 49-FR-8583 (March 8, 1984), as a Severity Level III violation (Supplement III). This violation is evidence of a security weakness. After consultation with the Director of the Office of Inspection and Enforcement, I have been authorized to issue the enclosed Notice of Violation and Proposed Imposition of Civil Penalty in the amount of Sixty Thousand Dollars (\$60,000). The base penalty of Fifty Thousand Dollars was increased by twenty percent because it is the second violation in the area of access control at Hatch plant in the past year. Had the licensee devoted sufficient attention to this area, this violation could have been prevented. We propose to impose this Civil Penalty to emphasize the need for Georgia Power Company to ensure that its security personnel adhere to establish procedural requirements.


