We have not included Group III in Dr. Wiggins' or Dr. O'Connor's authorization. In order to be authorized for Group III, a minimum of 5 generator elutions must be documented. Both Dr. Wiggins' and Dr. O'Connor's preceptor statements document only 3 elutions. Upon receipt of additional documentation we will add Group III to their authorization. Information submitted in response to this letter should state that it is additional information and not a new amendment request. If you have questions, please contact our office by dialing (312) 790-5625.

Please review the enclosed document carefully and be sure that you understand all conditions. You must conduct your program involving radioactive materials in accordance with the conditions of your NRC license, representations made in your license application, and NRC regulations. Request and obtain appropriate amendment if you plan to change ownership of your organization, change locations of radioactive material, or make any other changes in your facility or program which are contrary to your license conditions or representations made in your license application and any supplemental correspondence with NRC. Any amendment request should be accompanied by the appropriate fee specified in 10 CFR Part 170.

- 6. Submit a complete renewal application with proper fee or termination request at least 30 days before the expiration date on your license. You will receive a reminder notice approximately 90 days before the expiration date. Possession of radioactive material after your license expires is a violation of NPC regulations.
- 7. Request termination of your license if you plan to permanently discontinue activities involving radioactive material prior to your expiration date.

You will be periodically inspected by NRC. Failure to conduct your program in accordance with NRC regulations, license conditions and representations in your license application will result in enforcement action against you in accordance with the General Policy and Procedures for NRC Enforcement Actions, 10 CFR Part 2, Appendix C.
