Equipment Control	N R	Determine Containment Flood Level during Containment Flooding (A-RO-48) 2.2.44 – (4.2) Ability to interpret control room indications to verify the status and operation of a system, and understand how operator actions and directives affect plant and system conditions
Radiation Control	M R	Determine offsite rate (A-RO-47) 2.3.5 – (2.9) Ability to use radiation monitoring systems, such as fixed radiation monitors and alarms, portable survey instruments, personnel monitoring equipment, etc.

Conduct of Operations	D, R	Remote Shutdown Monitoring Instrumentation Channel Checks (A-SRO-39) 2.1.20 – (4.6) Ability to interpret and execute procedure steps.
Conduct of Operations	D, R	Determine Reportability Requirements (A-SRO-20) 2.1.18 – (3.8) Ability to make accurate, clear, and concise logs, records, status boards, and reports.
Equipment Control	M, R	Complete and Approve a Fire Protection Impairment (A-SRO-102) 2.2.17 – (3.8) Knowledge of the process for managing maintenance activities during power operations, such as risk assessments, work prioritization, and coordination with the transmission system operator.
Radiation Control	D, R	Authorize an Emergency Dose for a Life Saving Operation (A-SRO-37) 2.3.4 – (3.7) Knowledge of radiation exposure limits under normal and emergency conditions.
