Enclosed is Revision No. 0 to the Emergency Response Procedures (ERPs) for Limerick Generating Station (LGS), Units 1 and 2. The attached ERPs supersede the LGS Emergency Plan Implementing Procedures (EPIPs), and are being issued as a result of changes to the LGS Emergency Plan in order to support the activation of the common Emergency Operations Facility (EOF) and Emergency News Center (ENC) at Coatesville. These procedures were effective on April 1, 1992, and are required to be submitted within thirty (30) days of their implementation in accordance with 10 CFR 50, Appendix E, and 10 CFR 50.4.


