This refers to the inspection intended to promote public health and safety conducted by Mr. P. Patnaik of this office from July 6 - 10, 1992, at the Haddam Neck plant in Haddam, Connecticut. The findings of this inspection were discussed with your staff on July 10, 1992, at the conclusion of the inspection.

This inspection included a review of the long-term erosion/corrosion monitoring program for the high energy piping system and also an assessment of the engineering and technical support in carrying out plant design changes and modifications.

Within these areas, the inspection consisted of selective examinations of procedures and representative records, interviews with personnel and observations by the inspector. Within the scope of the inspection, no violations were observed and, therefore, no response to this letter is required. Your cooperation with us in this matter is appreciated.
