SUBJECT: NRC INSPECTION REPORT NO. 030-17220/92-01

This refers to the routine, unannounced inspection conducted by Mr. R. A. Brown of this office on August 12, 1992. The inspection included a review of activities authorized by Byproduct Material License No. 15-10819-03. At the conclusion of the inspection, the findings were discussed with members of your staff.

The inspection was an examination of activities conducted under the license as they relate to radiation safety and to compliance with the Commission's rules and regulations and the conditions of the license. The inspection consisted of selective examinations of procedures and representative records, interviews of personnel, and observation of activities in progress.

No violations or deviations were identified; therefore, no response to this letter is required.

The inspector determined that only a minimal amount of well-logging activities had been conducted by you under NRC jurisdiction. Discussions with your radiation safety officer were held to review the requirements for license termination and performing work under reciprocity.

Also reviewed were the actions you had taken with respect to the violations observed during our previous inspection conducted on March 22, 1990. The inspection verified that the corrective actions for these violations had been implemented as stated in your reply dated May 1, 1990, and that these actions were effective.

In accordance with 10 CFR 2.790 of the NRC's "Rules of Practice," a copy of this letter will be placed in the NRC Public Document Room.
