

Attached are sixty copies and three notarized originals of Amendment 59 to the Grand Gulf Nuclear Station Units 1 and 2 (GGNS) Final Safety Analysis Reports (FSAR).

Per discussion with members of your staff and Region II personnel on December 11, 1984, MP&L agreed to submit an FSAR amendment incorporating certain revisions to the startup test program as described in Chapter 14 of the GGNS FSAR. Please find attached Amendment 59 which incorporates the appropriate revisions to Chapter 14 of the GGNS FSAR. The majority of this information was previously transmitted to the NRC via letters AECM-83/0361, dated July 21, 1983; AECM-83/0483, dated August 23, 1983; and AECM-84/0029, dated January 11, 1984. These changes were subsequently approved by the NRC in letters to Mississippi Power & Light (MP&L) dated September 23, 1983 and February 3, 1984. Also included in Amendment 59 are changes to the startup test program that were previously submitted to the NRC in AECM-82/180, dated April 26, 1982. (This latter submittal was made prior to issuance of the GGNS low power operating license which explicitly required prior NRC approval of major changes to the startup test program.) It should be noted that an additional revision to Chapter 14 was made pertaining to main steam isolation valve minimum closing time. This revision was made in order to be consistent with the latest NRC position as indicated in Section 16.3.3(2) of Supplement 6 to the GGNS Safety Evaluation Report (Technical Specification Problem Sheet 25).

In addition to the revisions described above, MP&L has incorporated revisions into this amendment not previously transmitted to the NRC but which are considered to be editorial in nature and are not major modifications as defined by License Condition 2.C.(31).

As indicated in Region II Inspection Report No. 50-416/84-50, dated December 13, 1984, MP&L recognizes the need to revise the power-flow map in Chapter 14 (FSAR Figure 14.2-4) in order to reflect data obtained as a result

of the startup testing performed to date. These revisions are expected during the course of startup testing and pertain to the core flow rate associated with natural circulation and certain recirculation system conditions (curves A, B, C, and D on FSAR Figure 14.2-4). MP&L proposes to submit a single revision to the power-flow map, reflecting the final curve locations, at the conclusion of startup testing.

All changes submitted as part of Amendment 59 are provided to reflect the startup test program as it will be implemented at GGNS.
