Dear Sir:

Enclosed is Revision No. 0 of the Emergency Response Procedures - Common (ERP-C) for Limerick Generating Station (LGS), Units 1 and 2 and Peach Bottom Atomic Power Station (PBAPS), Units 2 and 3. These procedures should have been submitted within 30 days of their publication date of April 3, 1992. However, as a result of the major restructuring and reorganization which took place with the completion of our Common Emergency Operations Facility (EOF), the procedures were not submitted within the required time.

- ERP-C-1310, Rev. 0 - "Emergency Operations Facility (EOF) Dose Assessment Group."

Also being submitted with Revision No. 0 of these common procedures is Revision No. 1 of a selection of the same procedures. The enclosed Revision No. 1 procedures are also being submitted subsequent to the 30 day submittal period following the revision date of July 23, 1992 for the same reason explained above.


The following procedure revisions comprise Revision No. 1.

- ERP-C-Index, Rev. 1.
- ERP-C-1100, Rev. 1 - "EOF Staff Augmentation."

We also request that procedure ERP-C-1100, Rev. 1 identified above be withheld from public disclosure in accordance with 10 CFR 2.790(a)(6) since this procedure contains names and telephone numbers, and disclosure of this information would constitute an unwarranted invasion of the personal privacy of the individuals involved.
