REVIEW OF REGION II MATERIALS PROGRAM

This memorandum transmits to the Management Review Board (MRB) a proposed final report (Attachment 1) documenting the IMPEP review of the Region II (RII) materials program. The review of the RII program was conducted by an interoffice team from the Office of Nuclear Material Safety and Safeguards (NMSS), Region I, and a representative from the State of Georgia, from April 15-19, 1996. The team issued a draft report to the Region on June 4, 1996, for factual comment. The Region's comments (Attachment 2) have been incorporated into the proposed final report.

The team found RII's performance to be satisfactory with respect to the five common performance indicators, as well as with respect to the non-common performance indicators. Based on those indicators, the team concluded that the program was adequate to protect public health and safety. That finding was communicated to Regional management at the team's exit with the advisory that it was only the team's recommendation and was subject to change as a result of the MRB process.

The MRB meeting to consider the RII report is scheduled for Thursday, July 11, 1996, from 1:00 p.m. to 3:00 p.m. in One White Flint North, Rm. 8-B-11.
