This letter confirms verbal authorization provided to your office by RoseMary Mann, of my staff, to commence work under the subject task order effective August 21, 1992, with an established ceiling of \$10,000.

In accordance with the task order procedures of the subject contract, this letter definitizes Task Order No. 69. This effort shall be performed in accordance with the enclosed Statement of Work, the Contractor's revised proposal dated August 5, 1992, and the following telephonic changes of August 28, 1992:

- 1.) Reduce fixed fee by \$5.05 from \$19.57 (7.75%) to \$14.52 (5.75%).




