SUBJECT: NRC INSPECTION REPORT NO 50-458/92-30 (NOTICE OF VIOLATION)

This refers to the inspection conducted by Messrs. E. J. Ford, and the inspectors listed in the attached report, of this office on August 16 through September 26, 1992. The inspection included a review of activities authorized for your River Bend Station facility. At the conclusion of the inspection, the findings were discussed with you and those members of your staff identified in the enclosed report

Areas examined during the inspection are identified in the report. Within these areas, the inspection consisted of selective examination of procedures and representative records, interviews with personnel, and observations of activities in progress.

Based on the results of this inspection, certain licensed activities appeared to be in violation of NRC requirements, as specified in the enclosed Notice of Violation (Notice). The violation is of concern because you failed to control afeguards information that identified weaknesses and vulnerabilities in the physical security of River Bend Station. This information, if compromised, could have been used to gain unauthorized or undetected access to the protected area.

The NRC is also concerned about your reluctance to report the manual reactor scram of September 11, 1992. This report was made only after significant NRC involvement. This scram was initiated from a power level significantly higher than the routine shutdown procedure and was prompted by uncontrolled and deteriorating equipment problems. This type of transient is of interest to the NRC so that the agency can perform a prompt assessment of the potential or actual safety significance of the event and fulfill our responsibilities of emergency response.

You are required to respond to this letter and should follow the instructions specified in the enclosed Notice when preparing your response. In your response you should document the specific actions taken and any additional actions you plan to prevent recurrence. After reviewing your response to this Notice, including your proposed corrective actions and the results of future

inspections, the NRC will determine whether further NRC enforcement action is necessary to ensure compliance with NRC regulatory requirements.
