Carol,

NTEC's Cordero Mine, located in Gillette Wyoming has (2) Thermo Fisher nuclear coal analyzers. (License 49-29429-01)

They are due for swipe testing in April 2020. With the ongoing Coronavirus pandemic, along with social distancing and travel restrictions, I am seeking an exemption to delay the scheduled swipe testing until the current restrictions are eased. (10 CFR Regulation 34.27(c)(1))

At this printing, I am assuming that these restrictions will be eased within the next 30 - 45 days. We contract with a 3rd party company, (Thermo Fisher Scientific) who normally comes to our site and preforms the testing. They are not a local company and have to travel from out of state to get to our site. This is a difficult task in the current environment.

Assuming that the requested delay is granted, we would plan to reschedule as soon as possible after the restrictions are eased. I would also provide notice once testing had been completed.

I appreciate your consideration to our dilemma to complete the swipe testing in the normal scheduled period.
