Gentlemen:

This refers to the physical security inspection conducted by Mr. Ronald A. Caldwell of this office during the period March 11-14, 1985, of activities authorized by NRC Operating License Permit DPR-34 for Fort St. Vrain Nuclear Station, and to the discussion of our findings with Mr. C. H. Fuller and other members of your staff at the conclusion of the inspection.

Areas examined during the inspection included the security organization, security program audit, records and reports, and alarm stations. Within these areas, the inspection consisted of selective examination of procedures and representative records, interviews with personnel, and observations by the inspector. These findings are documented in the enclosed inspection report.

Within the scope of the inspection, no violations or deviations were identified.
