In response to Supplement 1 of Bulletin 92-01, Yankee Atomic Electric Company (YAEC) has reviewed the actions required and has determined that our original response in Reference (c) remains unchanged. No further action is required by YAEC.

Utilization of Thermo-Lag 330 at the Yankee Nuclear Power Station (YNPS) was limited to a one half hour radiant heat shield for a section of three-inch conduit containing the cable for one of the redundant nuclear source range channels. The radiant heat shield used 1/4 inch Thermo-Lag 330 preshaped conduit sections installed in accordance with Thermal Science, Inc. instructions.

YNPS is permanently shutdown and defueled. The YNPS Possession Only License prohibits transfer of spent fuel from the Spent Fuel Pit to the Vapor Container. The nuclear source range channels, cables and issociated heat shield are no longer required operable or functional. Thus, no compensatory measures are required.
