
SUBJECT: CALLAWAY SECURITY PLAN, REVISION 24

We have received your letter dated June 20, 1996, including Revision 24 to the Callaway Security Plan. Our review found the changes to the plan to be consistent with the provisions of 10 CFR 50.54(p), subject to the following described condition.

During our review of Revision 24, we identified one item that was discussed during a telephone conversation between Messrs. J. Clark of your staff and D. Schaefer of this office on July 16, 1996. During this telephone conversation Mr. Clark agreed that the next revision to your security plan would change paragraph 12.2 to read that specified hatches and doors will be "tested quarterly or whenever opened for operational maintenance or repairs, whichever is shorter."

The enclosure to your letter contains Safeguards Information of a type specified in 10 CFR 73.21 and is being withheld from public disclosure.
