Dear Ms. McCullough:

Your letter to the former U.S. Nuclear Regulatory Commission (NRC) Chairman, Lando Zech, transmitting a copy of a letter from you to Mr. Welch, President of the General Electric Company, has been referred to me for response. As you requested, we have reviewed your letter to Mr. Welch to determine if the NRC can assist you in addressing the health issues you have raised. We have determined that your letter relates to matters which are beyond the NRC's jurisdiction, which is limited to the regulation and control of the use of radioactive materials and nuclear facilities. However, we note that you have sent copies of your letter to some of the Federal agencies with responsibilities in the area of work-related injuries. Perhaps they may be able to assist you.
