Dear Mr. Shear:

I am in receipt of the above referenced notice of violation. I have reviewed our current procedures with Phil Hegge and Mike Nugent. It appears that there was a misinterpretation on the part of the person doing the referenced surveys. This occurred at a time when our work with radioisotopes was being greatly reduced. A plan has been devised to preclude this from happening in the future. Specifically, a survey checkoff chart has been devised, copy attached, which details when surveys need to be done for each area of the building given the current level of work. This sheet will be worked out jointly between Mr. Hegge and M Nugent at the beginning of the year and will only be altered if there is a clange in our isotope usage. Any time there is a change in the level of isotope usage Mr. Hegge and Mr. Nugent will mect to decide if the schedule needs to be revised. If a revision is required a new schedule will be created and placed in front of the old schedule in the three ring binder in which the current surveys are being kept. I feel this new procedure will help to alleviate any future confusion regarding the survey requirements of our license.
