This refers to Frank Barker Associates, Inc., letters dated August 15, 1995, August 16, 1995, August 18, 1995, October 13, 1995, October 25, 1995, October 26, 1995, October 31, 1995, November 8, 1995, November 10, 1995, January 4, 1996, April 15, 1996, and May 30, 1996, with enclosures thereto, submitted in response to our Confirmatory Action Letter (CAL) NMSS-95-001, dated August 8, 1995. Based on the information submitted by Frank Barker Associates, Inc., the NRC has found that all the commitments listed in the CAL have been met.

Based on the information in your letter dated May 30, 1996, we understand all adapters of the style involved in the two incidents discussed in CAL NMSS-95-001 have been returned to you. In addition, we understand that all of the originally approved style adapters have been returned to you with the exception of the three listed in your letter dated May 30, 1996. This fulfills the requirement in the CAL that you provide a list of all users still possessing any older style adapters. We also understand that all users, including the three listed in your May 30, 1996, letter, have been supplied with the new modified style adapters.

No further response is required regarding the CAL.
