SUBJECT: RADIOLOGICAL SURVEY INSPECTION (REPORT NO. 40-06322/96-01)

This refers to the special inspection conducted by Mr. H. Dean Chaney on February 28, 1996, of the facilities formerly used by the Cal-State Metals, formerly located at 2101-2127 West Rosecrans Avenue, Gardena, California. Activities involving the use of radioactive materials were previously authorized by an Atomic Energy Commission (AEC) Source Material License No. STC-00098. The results of our inspection findings were discussed with you via telephone at the conclusion of the inspections on February 28, 1996.

The enclosed inspection report identifies areas examined during the inspection. The inspection consisted of independent radiological surveys and measurements of the vacant lot and areas around the adjacent buildings located at 2129-2145 West Rosecrans Avenue, Gardena, California (former location of 2101-2127 Rosecrans Ave.). This site is located on West Rosecrans Avenue between the cross streets of Western Avenue (east) and Van Ness Avenue (west).

Based upon the inspection findings (radiological survey), we have determined that the grounds located at the above referenced addresses do not have any apparent residual radioactive contamination due to previous AEC licensed activities, that is detectable with our instrumentation. No anomalous readings above established background levels were observed during the surveys. Consequently, we have no further questions regarding this matter.

In accordance with 10 CFR 2.790 of the Commission's regulations, a copy of this letter and the enclosed inspection report will be placed in the NRC Public Document Room.
