SUBJECT: NRC INSPECTION REPORT 50-344/96-01

This refers to the inspection conducted by Messrs. Lee Thonus and Paul Harris of the Office of Nuclear Reactor Regulation and Mr. Vincent Everett of this office on April 1 through April 12, 1996, at the Trojan Nuclear Plant facility. The purpose of the inspection was to determine whether activities authorized by the license were conducted safely and in accordance with NRC requirements. At the conclusion of the inspection, the findings were discussed with you and those members of your staff identified in the enclosed report.

Areas examined during the inspection are identified in the report. The primary focus of this inspection was to review health physics activities, evaluation of the employee concern program, implementation of the new 49 CFR and 10 CFR Part 71 regulations, effectiveness of the commitment tracking system, compliance with the NRC Memorandum and Order CLI 95-13 limiting decommissioning activities, and closure of Licensee Event Report 95-01 concerning the manning of the control room. Within these areas, the inspection consisted of selective examinations of procedures and representative records, interviews with personnel, and observation of activities in progress. The results of this inspection are documented in the enclosed report.

In accordance with 10 CFR 2.790 of the NRC's "Rules of Practice," a copy of this letter and its enclosures will be placed in the NRC Public Document Room.
