Tom Hansen Co., Inc. Hereby request renewal of the about described materials license with the following additions and/or corrections.

In regard to our current license and the radionuclides which we are currently using, the following corrections should be made. Amendment No. 05, dated 1-24-83 (Exhibit A) Conditions 6, 7 & 8. supersedes and replaces Amendment No. 02 dated 12-28-81 (Exhibit B) Conditions 6, 7 & 8. In accordance with Amendment No. 05, Condition 9.; "Authorized Use", of our materials license should be modified to read: "A, B & E to be used for oil and gas well logging".

The above described corrections, when incorporated into our license, will reflect our current program as it pertains to: (1) Condition 6. By product, sources, and/or special material; (2) Condition 7. Chemical and or physical form; (3) Condition 8. Maximum amount that licensee may possess at any one time under this license; (4) Condition 9. Authorized use.

Concerning Condition 12. i.e., Management Control, Amendment No. 04, dated 1-5-83 (Exhibit C) designating Paul E. Knight as Corporate Radiation Safety Officer and/or Thomas M. Rose as Radiation Safety Officer, Oklahoma Division. This amendment supersedes and replaces all others concerning management control and should be incorporated into our new license.

Concerning Condition 10. wherein licensed materials may be used and/or stored. Amendment No. 06, dated 3-3-83 (Exhibit D) reflects all facilities currently using and/or storing any radionuclides. In respect to Condition 10. Amendment No. 06, dated 3-3-83 (Exhibit D) supersedes and replaces Amendment No. 01 dated 5-8-81 (Exhibit E), Amendment No. 02, dated 12-28-81 (Exhibit B), Amendment No. 03 dated 11-2-82 (Exhibit F), and Amendment No. 04 dated 1-5-83 (Exhibit C).
