Dear Mr. Quay:

The enclosure to this letter provides a draft chapter to the WGOTHIC Applications Report scheduled for completion in June. The draft chapter describes the method for calculating the PCS film coverage input used in the AP600 containment DBA evaluation model. Planned additions to the chapter which are not reflected in the enclosed draft include incorporation of information to address the effect of baffle standoffs and information to assess the WGOTHIC model sensitivity to film temperature input. The draft chapter is provided at this time to allow the staff to begin their review of the PCS water coverage model. Comments and questions on the enclosure would be appreciated by June 17, 1996.
