Dear Ms. Stephens:

This is in response to your letters dated July 20, 1984 and August 24, 1984, in which you requested, pursuant to the Freedom of Information Act, information regarding the relocation of the Wolf Creek Local Public Document Room.

The documents listed on Appendix A are enclosed.

The three documents listed on Appendix B are being withheld in their entirety from public disclosure pursuant to Exemption (5) of the Freedom of Information Act (5 U.S.C. 552(b)(5)) and 10 CFR 9.5(a)(5) of the Commission's regulations. These documents are draft letters which contain the preliminary advice, opinions, and recommendations of a staff member of the Local Public Document Room (LPDR) Branch to me. As such these drafts do not reflect a final agency position. Release of these draft documents would tend to inhibit the open and frank exchange of ideas between subordinates and their supervisors, and therefore is not in the public interest. The final versions of these documents are documents 1 through 5, 10 and 11 on Appendix A.

Pursuant to 10 CFR 9.9 of the Commission's regulations, it has been determined that the information withheld is exempt from production or disclosure, and that its production or disclosure is contrary to the public interest. The person responsible for this denial is the undersigned.

This denial may be appealed to the Commission's Executive Director for Operations within 30 days from the receipt of this letter. As provided in 10 CFR 9.11, any such appeal must be in writing, addressed to the Executive Director for Operations, U.S. Nuclear Regulatory Commission, Washington, D.C. 20555, and should clearly state on the envelope and in the letter that it is an "Appeal from an Initial FOIA Decision."
