Dear Mr. Quay:

The reference 1 letter provided Westinghouse responses to NRC Requests for Additional Information (RAI) on the NOTRUMP computer code. The RAIs contain information which is proprietary to Westinghouse. Your letter of August 16, 1996 noted that we needed to specifically identify those portions that were proprietary and provide a nonproprietary version of the responses.


