Subject: Modification No. 1 to Task Order No. 1 Entitled "Response
Technical Manual Training Materials Development" Under Contract
No. NRC-26-93-296

This modification is issued to ratify some of the unauthorized costs incurred under this task order and allow payment in the amount of \$17,476.34 for work performed without Contracting Officer authorization. This ratification action will modify the task order to: (1) revise the statement of work; (2) extend the period of performance; (3) increase the task order ceiling amount by \$17,476.34, from \$133,831.00 to \$151,307.34; and (4) increase the amount obligated by \$17,476.34, from \$133,831.00 to \$151,307.34.

The task order is therefore modified, as follows:

1. The task order shall be modified to include the effort described in the attached Statement of Work.
2. The second paragraph of the definitization letter is deleted in its entirety and replaced with the following:

"Task Order No. 1 shall be in effect from September 13, 1993, to June 12, 1994, with a cost ceiling of \$151,307.34. The amount of \$141,408.73 represents the total estimated reimbursable costs, and the amount of \$9,898.61 represents the fixed fee."

3. The third paragraph of the definitization letter is deleted in its entirety and replaced with the following:

"The obligated amount of this task order is \$151,307.34."




