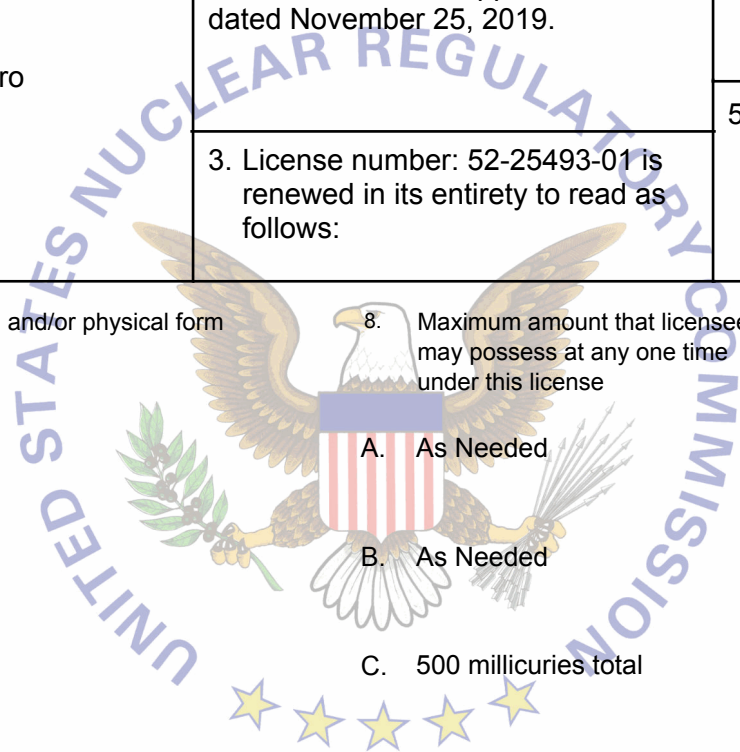


MATERIALS LICENSE
