Cardinal Health 414, LLC (hereafter Cardinal Health) submits a request to the U.S. Nuclear Regulatory Commission (hereafter NRC) for regulatory relief during the COVID-19 PHE for 10 CFR Part 20.2206(c) in italics below.

The licensee shall file the report required by § 20.2206(b), covering the preceding year, on or before April 30 of each year. The licensee shall submit the report to the REIRS Project Manager by an appropriate method listed in § 20.1007 or via the REIRS Web site at <http://www.reirs.com>.


As a result of the COVID-19 PHE, there have been several changes in business operations at Cardinal Health which have inhibited the ability to meet the April 30 deadline. These operational changes have led to challenges in compiling all individual dosimetry data Form NRC 5 data and in the validation of the data. As a result, Cardinal Health requests regulatory relief in the form of a 45-day extension to submit the information required by the Form NRC 5 to ensure that the data submitted is complete and accurate.
