A. Technical Approach

1. Soundness of offeror's technical approach to the stated tasks in a timely manner and the likelihood for success for the proposed tasks. (15 points)
2. Extent the proposal reflects the offeror's understanding of the requirements set forth in the Statement of Work. (15 points)
3. The extent to which the offeror can provide the nuclear, mechanical, civil and earth science related disciplines and specialties to match the technical needs of the tasks. (10 points)

B. Related Past Experience

(35)

1. Extent the offeror has demonstrated past experience and knowledge related to the storage and handling of spent nuclear fuel and high-level waste. (20 points)
2. Extent of education and background related to engineering analysis of the structure, systems, and components important to safety in nuclear facilities. (15 points)

C. Project Management

(25)

1. The extent to which the offeror demonstrates the ability to produce a quality product within the stated time constraints. (20 points)
2. The extent to which computer, editorial and other clerical services will be available to support the completion of the project. (5 points)"
