Supplement No. 1 to License Amendment Request Dated May 17, 1985

In our License Amendment Request dated May 17, 1985 we submitted proposed Technical Specification changes which would allow the use of steam generator tube sleeving repairs. The purpose of this letter is to supplement our May 17, 1985 request with proprietary versions of the two Westinghouse topical reports included as Appendices C and D of that submittal.

Also enclosed are Westinghouse authorization letters CAW-85-022 and CAW-85-027 and accompanying affidavits.


