CHANGES IN SUBSCRIBING COMPANIES AND IN THEIR PROPORTIONATE LIABILITY ENDORSEMENT

It is agreed that with respect to bodily injury or property damage caused, during the effective period of this endorsement, by the nuclear energy hazar':

- 1. The word "companies" wherever used in the policy means the subscribing companies listed below.
