Dear Mr. Kharrl:

During the period February 12-13, 2020, the Nuclear Regulatory Commission (NRC) administered a partial retake operating test to one employee of your company who had applied for a license to operate the Joseph M. Farley Nuclear Plant. At the conclusion of the test, the examiner discussed preliminary findings related to the retake operating test with those members of your staff identified in the enclosed report.

One Senior Reactor Operator (SRO) applicant passed the administrative JPM portion retake of the operating test. There were no post-administration comments. The applicant was issued a license commensurate with the level of examination administered.

All examination changes agreed upon between the NRC and your staff were made according to NUREG-1021, "Operator Licensing Examination Standards for Power Reactors," Revision 11.

SUMMARY

ER 05000348/2020302, 05000364/2020302; February 10 - 13, 2020; Joseph M. Farley Nuclear Plant; Operator License Examinations.

A Nuclear Regulatory Commission (NRC) examiner conducted an retake examination in accordance with the guidelines in Revision 11 of NUREG-1021, "Operator Licensing Examination Standards for Power Reactors." This examination implemented the operator licensing requirements identified in 10 CFR §55.41, §55.43, and §55.45, as applicable.

The administrative JPM portion of the operating test was developed by the licensee.

The NRC administered the operating test during the period February 10-13, 2020. One Senior Reactor Operator (SRO) applicant passed the retake administrative JPMs portion operating test. The systems JPMs, the simulator scenario portion of the operating test, and the written examination were excused. The applicant was issued a license commensurate with the level of examination administered.

There were no post-examination comments.

No findings were identified.

4. OTHER ACTIVITIES

4OA5 Operator Licensing Examinations

a. Inspection Scope

The NRC reviewed the licensee's examination security measures while preparing and administering the examinations in order to ensure compliance with 10 CFR §55.49, "Integrity of examinations and tests."

The NRC administered the administrative JPM portion of the operating tests during the period February 10 - 13, 2020. The NRC examiner evaluated one Senior Reactor Operator (SRO) applicant using the guidelines contained in NUREG-1021. Evaluation of applicant and review of associated documentation was performed to determine if the applicant, who applied for licenses to operate the Joseph M. Farley Nuclear Plant, met the requirements specified in 10 CFR Part 55, "Operators' Licenses."

b. Findings

No findings were identified.

The licensee developed the operating test. All examination material was developed in accordance with the guidelines contained in Revision 11 of NUREG-1021. The NRC examination team reviewed the proposed examination. Examination changes agreed upon between the NRC and the licensee were made per NUREG-1021 and incorporated into the final version of the examination materials.

One Senior Reactor Operator (SRO) applicant passed the administrative JPM portion of the operating test. The systems JPMs, the simulator scenario portion of the operating test, and the written examination were excused. The SRO applicant was issued a license.

A copy of the individual examination report was sent to the facility Training Manager for evaluation of weaknesses and determination of appropriate remedial training.

The licensee submitted no post-examination comments.

4OA6 Meetings, Including Exit

Exit Meeting Summary

On February 13, 2020 the NRC Chief Examiner discussed generic issues associated with the operating test with J. Austin, Training Director, Joseph M. Farley Nuclear Plant, and other members of the Joseph M. Farley Nuclear Plant staff. The examiner asked the licensee if any of the examination material was proprietary. No proprietary information was identified. On March 13, 2020, the Chief Examiner discussed final examination results with the Training Staff.
