

TMI Hearing - March 2, 1981 - Written Statement

To Members of the Atomic Safety
and Licensing Board:

These comments express my extreme
opposition to the Unit 1 restart at
Three Mile Island. Actually, I support
a moratorium on all nuclear power
installation construction and licensing --
particularly in population dense areas.

My husband and I own both a home and
an investment property in this area. We
have been hard working, and we have
been careful in spending. That is how
we came to own two properties in our
thirties. Our early energy conserving
efforts were undertaken for our own
pocketbooks, seeking to decrease our fuel
and electric use (waste) and, thus, our costs.
Now we have an even greater interest
in limiting our energy use. We don't
want to be any part of an excuse to
promote nuclear energy -- especially the
restart of TMI's reactors. In fact, I
would favor enforced conservation to

reduce the glutinous waste of energy observable all around us. The way I see it -- we, the consumers, are the camel's back; the utilities combined with our excessive energy use are our burden; and the accident at Three Mile Island is the straw, the back-breaking, final straw.

My family has been here in Central Pennsylvania through many generations. Rural people, mostly, lovers of the land. I never again want us to be terrorized by a report of the T.M.I. accident. The loss of one beloved person is grief -- yet it is part of life's experience. But the loss of security of all ties, of lifelong investments in property through the dispersal of family and friends, on the ruin from technology gone haywire, is heartache beyond speaking. It is part of life's experience only if we allow it to become so.

The benefits of the restart of T.M.I. Unit 1 are not worth the risks to this area's population and environment. It would be tragic enough for an accident or chronic leakages to contaminate the fields and hills and streams of any area.

MOX-ED's installation, however puts several hundred thousand people in jeopardy of being uprooted and losing everything, not even considering health risks. Even the "potential" for another accident is enough to endanger our peace of mind, which is mighty ~~hard~~ hard to come by these days anyway.

I am sickened when I hear long-sounding sirens. And it's not fire that comes to mind. It's another "incident" at TMI.

Because TMI is part of the whole, I want to make some comments that apply to nuclear power, in general, as well as TMI in particular. I believe the touted low cost of nuclear power is a fraud, due to 1/ government subsidy and 2/ inadequate expenditure on safety, siting, and accident coverage. This nation is not prepared for the use of nuclear power as a major resource. Critical problems include a shortage of trained technologists, waste disposal questions, and extremely inadequate planning and compensation for accident victims.

Our next home will be small and of passive solar construction. Interest in such construction is definitely on the rise. People neither want to pay for nuclear power nor contribute to its expense.

We want to remain in this area, but plan to build at least 20 miles west of TMI, should the Nuclear Regulatory Commission fail us and allow TMI to be reactivated.

No one, they say, has died yet from nuclear power. That's many of our neighbors. For myself and many I know, we would not want to live as well since the accident. Or should I say, with the same sense of well-being. We did have our eyes opened, and that is good. But a sense of well-being one enjoys by living in a certain area is hard to put a price on and to figure into cost/benefit analysis. Believe me, though, we felt its loss.


Please do not allow the reactors to go back on line.

Citizen comment on the proposed re-starting of TMI Unit 1

I have two comments to make. One concerns public policy; the other TMI.

First, I contend that all federal research and development projects for nuclear technology should cease. President Reagan asserts that the private sector is the proper place for the development of solar and other alternate energy sources, and has proposed to cut the use of federal funds for that purpose.

I agree with him, and believe his philosophy should apply to nuclear energy as well as solar. If nuclear energy is such a great idea, let the utilities fund their own research and development. Helping utilities to terrorize communities is not a legitimate use of tax dollars, in my opinion.

The federal government's only role should be to police the nuclear industry to ensure public safety. And it should do a much better police job in the future than it has in the past.

As for Three Mile Island, I inalterably oppose returning Unit 1 to service. I have no confidence in Metropolitan Edison's competence to operate TMI safely. But even more to the point, I have no faith in nuclear technology. I do not believe it is necessary, and I do not believe that it is safe enough to be part of our community.

I do believe that sooner or later some town of people like us will pay a very high price for the Faustian bargain of nuclear power. But I have paid a high enough price -- both monetarily and emotionally -- and I do not intend to pay any more than it takes to eliminate TMI from my life.

Especially, I intend to reclaim that peace of mind which is my right. When I think of the terror I and my family endured two years ago, of the flight from our home and the restless nights, of the deceit practiced by virtually everyone in authority, of the frightening question that intrudes every time we hear a siren, then I think again that we have had enough.

You, of course, have a vested interest in promoting nuclear energy and, therefore, in opening TMI for business again. Unfortunately, you also have the authority to do that. You can ignore what I want. You can walk away from the abiding harm that TMI has caused our community. You can refuse to admit my determination not to have TMI operate again.

But if you do, at least show enough responsibility to make certain that we are prepared the next time someone from Metropolitan Edison decides that federal regulations are too inconvenient for compliance. Make sure that when it happens again you can evacuate people with mind and body intact. And I don't mean to make sure on paper. Make sure by doing it. Conduct a full evacuation of the Harrisburg area to test your plans. Then revise your plans and do it again until you get it right. And then, just maybe, you should consider what to do with TMI.

Until then, I want my message to be clear. I want to be secure in my home. I want to choose the risks that I will live with.

I want TMI shut down forever as a nuclear power plant.

Dear Sirs:

You have been hearing only legalities. I hope you will consider some common sense arguments as well when deciding whether or not to restart TMI-1.

We don't need it. Even the NRC staff admits we have enough electricity to cover our needs for the next two years. And consumption is going down.

Every time MetEd is allowed to release gas or water to our environment, they tell us not to worry-it is really nothing-compared to what an operating plant discharges. We don't like what they call nothing. We certainly don't want what they call significant releases-those connected with an operating plant.

We have already had an undetermined amount of radioactivity. We have a possibility of a lot more before cleanup of Unit 2 is done. No-one can even estimate how much more we will get. And now someone wants to give us another dose deliberately? How could anyone even consider such a thing.

The waste from Unit-2 has created a nuclear waste dump-some high level and some low level. Isn't that enough for one community? And all this waste can leak-and has been leaking. It is too much to live with and it certainly is unsafe to have anyone working beside it in another plant. NRC protests that a flood-prone island is no place to put waste. Neither should it be a place to create any more.

You cannot now remove high level waste from that island. By July you may have only one place in the whole country where you can take the low level waste. Why would anyone create more that we cannot remove?

Running a nuclear plant is dependent upon having a company which is meticulous in its attention to safety. So far MetEd in the past two years since the accident (we won't even talk about before the accident) has accidentally dumped water twice, has had to release it into unit 1 once, has spilled sulphuric acid, has neglected to properly screen employees, has not searched employees thoroughly, has had a control room protected by a looped rope, and has been cited several times by the NRC because it did not properly package waste to be shipped out. That sounds sloppy to me-something we can't afford in nuclear management.

Because of their finances, there is serious question that MetEd can clean up Unit 2. On the brink of bankruptcy how can they hire the hundreds of workers needed to run another plant? How can they put in the safety systems needed for protection? Or do the maintenance and surveillance necessary to protect public and worker health?

Since the accident we have never had a successful civil defense exercise. They botched each one they tried. Furthermore civil defense plans have been kept secret by most local governments and by state government. How can citizens be prepared when nothing has been published in two years? No state worker in Harrisburg has ever been told what to do in an emergency and there has never been a drill of any kind. Hospitals, prisons, schools-none are prepared.

Many emergency plans call for things like having DER take radiation readings in the area. DER has added a couple public relations people since the accident but no engineers and very little equipment.


These are not emotional arguments. These do not just claim stress. They are common sense. I hope there is a place in your deliberation for asking questions about ordinary events and plans as well as scientific and legal sophistries.







To Whom It May Concern:

As a resident of 12 Burd Rd. in Middletown, Pa. I have very grave concerns about the restart of Unit I at Three Mile Island.

I do not feel that it's reasonable to operate a nuclear generating plant at the same site and at the same time that a crippled reactor is down.

Since the March 1979 accident with Unit II much controversy has arisen over operating & safety procedures with nuclear power plants. These have not been resolved as yet and it's

ridiculous to assume that there won't be additional problems with Unit II.

To restart Unit I would put



additional burdens on the staff at the plant and adds to the risk of Unit I developing problems as it operates. Personally, I feel nuclear power just can't "go away" as we are a country that uses much energy. However, there has to be more safeguards imposed and the industry should be made to go slower. One can't expect a company, who exists to turn a profit, to adequately police itself. This is best handled by the government. ^{Also} I believe a military presence on the island to ensure security is the only reasonable answer to policing against outsiders, such as terrorist groups.

As for operating safety, the Met-Ed Co. has bungled much in the past months and left area residents feeling very insecure. An accident like TMI-2 has never occurred before and there's still too much to learn in

regards to correcting the damage done to enable the same company to operate Unit I while still dealing with the problems of Unit II is a terrible injustice to area residents who already feel the stress from lack of confidence in the nuclear industry.

Healthwise, I'm concerning myself with thoughts of more radioactive releases both planned & unplanned. Now, GAU wants to add "normal background" radiation from the plant by operating UNIT I. This is upsetting to me & I feel that it does have a health effect on the public. We don't as yet know the long term effects of low-level radiation. We are actually the human guinea-pigs who will be statistics sometime, either for better or worse.

Please consider the views of the people living next door to this power

plant. This is our home and we want to feel as secure living here as we have a right to feel.

Please don't think only of \$ and ¢ in relation to this issue. The nuclear issue is still very controversial and your decision will affect the entire nation. You must include considerations of the general public in all you do because we are always going to be directly affected, both economically and health-wise.







I would urge you NOT TO RETURN IT TO SERVICE, as the hazards here far outweigh the value in its operation.



It has come to my attention that serious consideration is being given to restarting TMI-1. I honestly cannot understand how anyone can consider operating unit-1 beside contaminated unit-2. It seems obvious to me that neither Met. Ed. nor G&E nor the NRC has had the time nor the energy to properly address TMI-2 clean-up. Now, then, can we seriously consider carrying on both the clean-up (unit-2) and operation (unit-1) at the same time?

My family and friends experienced the TMI-2 incident with great anxiety, and we retain a paranoia regarding nuclear production of energy. This paranoia extends beyond the mere fear of another accident if unit-1 is restarted. We watch carefully and constantly fear similar incidents at the Peach Bottom plant. But even further, we question the powers that be, who we assessed were examining new proposals for energy production. Many of us had faith in our government to test and reject plans to build and operate such facilities with our safety in mind. We never imagined that the regulatory and licensing bodies would allow such a potential danger to exist in our midst without strict preparing the civil defense with evacuation plans and then monitoring safety procedures closely and repeatedly, throughout the unit's operation. Well, we have come to learn that our safety does not seem to be as important as the utility's profit or the satisfaction of this nation's gluttonous desire for energy.

I noticed a statement at the bottom of my electric bill "informing" me that the cost of my electric would not be so high if TMI-1 were operating. I think that is a low blow from Met. Ed. to even imply that the TMI-1 restart issue is just that simple - after all they've put us through.

I do not agree with restarting TMI-1 now. I hesitate to say that I would ever agree with TMI-1's restart given the fears I still have. However, I implore you to at least consider revising the area evacuation plans and completely cleaning up TMI-2 before even considering putting any unit on that island on line.
