Subject: Management Meeting

On December 14, 1992, Messrs. R. Pagodin and G. Morgan of your staff met with Mr. R. Keimig and other NRC staff members at the NRC Region I office in King of Prussia, Pennsylvania. The meeting was requested by your staff to discuss several matters related to the physical security program at the Vermont Yankee Nuclear Power Station. A list of attendees is enclosed with this letter.

The principal matters discussed during the meeting were: (1) the transition plan for changing the security force contractor from Green Mountain Security Services to the Wackenhutt Corporation; (2) the status of the assessment system upgrades; (3) the plans for modifying the intrusion detection system; (4) the acquisition and use of new tactical equipment, plans and weapons; and (5) the general status of the security program.

Details of our discussions are deemed to be Safeguards Information and are exempt from public disclosure in accordance with 10 CFR 73.71.

We appreciate your staff's initiative in requesting the meeting and their efforts in compiling the information that was presented. We found the meeting beneficial in providing the NRC with a comprehensive overview of existing and planned security program activities.
