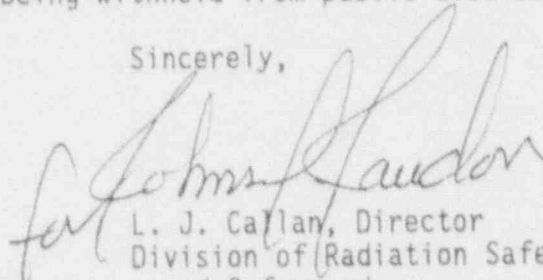
SUBJECT: COOPER NUCLEAR STATION SAFEGUARDS PLAN

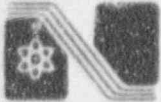
