Dear Sir:

As discussed in our telephone conference, enclosed is a revised Technical Specification page 3/4 3-35, Remote Shutdown Monitoring Instrumentation. This revision combines the current Technical Specification with a portion of our previously proposed Technical Specification change request, TSCRN 124. Specifically, this revision replaces the current readout location, ES Switchgear Room, for several instruments with the readout location from our proposed change request, Remote Shutdown Panel. Our original change request specified operability and surveillance requirements for the control transfer switches and for certain instrumentation and controls on the Remote Shutdown Panel. Since this revision is within the scope of the original change request, which was noticed in the Federal Register, re-noticing should not be necessary.

We understand from conversations with you and the staff that the staff has deferred review of Technical Specification change request for new Remote Shutdown Systems. Please note that this revision does not incorporate the new system into the Technical Specifications but provides an administrative change to the current specification in the form of updated readout locations. This revision is


