

SUPPLEMENTAL AGREEMENT
BETWEEN
THE UNIVERSITY OF NEBRASKA-LINCOLN
AND
THE U. S. NUCLEAR REGULATORY COMMISSION

THIS SUPPLEMENTAL AGREEMENT, effective the 13th day of April, 1981, by and between the UNITED STATES OF AMERICA (hereinafter referred to as the "Government"), as represented by the UNITED STATES NUCLEAR REGULATORY COMMISSION (hereinafter referred to as the "Commission"), and THE UNIVERSITY OF NEBRASKA-LINCOLN (hereinafter referred to as the "Contractor"),

WITNESSETH THAT:

WHEREAS, the parties desire to modify Contract No. NRC-04-76-315 as hereinafter provided, and this supplemental agreement is authorized by law, including the Energy Reorganization Act of 1974, as amended, and the Atomic Energy Act of 1954, as amended.

NOW, THEREFORE, said contract is hereby modified as follows:

1. Appendix A, attached to this supplemental agreement and made a part hereof, provides for the research to be performed by the Contractor during the contract period specified therein.
2. In Article II - The Period of Performance, the date "June 30, 1982" is substituted for the date "June 30, 1981".
3. In Article III - Consideration, the sum "\$460,253.00" is substituted for the sum "\$379,545.00".

For the Contract period July 1, 1981 through June 30, 1982

Article A-I RESEARCH TO BE PERFORMED BY CONTRACTOR

(a) The scope of work under this contract is unclassified and shall be in accordance with Contractor's proposal entitled, "A Study of Regional tectonics and Seismicity for Nebraska" and is as follows:

- 1) Continue gravity data collection.
- 2) Continue ground magnetics data collection.
- 3) Collect geologic data by field mapping in an area surrounding the northern extension of the Humboldt Fault.
- 4) Continue seismic program.
- 5) Integrate previous NRC studies in Nebraska with NRC studies from surrounding states and prepare a five year summary report.

(b) The Principal Investigator expects to devote the following approximate amount(s) of time to the contract work:

R. Burchett: 40% of his time for 12 months.
