

1. He is Vice President of Philadelphia Electric Company, Licensee under Facility Operating Licenses DPR-44 and DPR-56 for Peach Bottom Atomic Power Station, Units 2 and 3, and is authorized to execute this affidavit;


2. He has reviewed revised pages of the Physical Security Plan for Peach Bottom Atomic Power Station dated June, 1985 (hereinafter the "Revisions") and knows the contents thereof. The Revisions will not reduce the safeguards effectiveness of the Plan;

3. The Revisions which are sought to be withheld from public disclosure contain details relating to the physical security plans for Peach Bottom Atomic Power Station;


4. The information set forth in the Revisions has been treated as confidential and proprietary information and has been withheld from public disclosure by Licensee in accordance with Licensee's practice of treating all information dealing with the details of security plans as confidential and proprietary information, and;

5. The Revisions should be considered by the NRC as confidential and proprietary information and be withheld from public disclosure on the grounds that they contain Safeguards Information, they contain details relating to the physical security plans of a licensed facility, they contain

detailed information which could be used to compromise the safety and security of the facility, such disclosure is not required in the public interest and such disclosure would adversely affect the interests of Philadelphia Electric Company.
