The staff is continuing its review of your Station Blackout/Electrical Safeguards Upgrade (SBO/ESU) Design Report, Revision 1 dated December 23, 1991. Our evaluation of the Diesel Generator Qualification Plan was forwarded on January 31, 1990. Our evaluation of your 10 CFR 50.63 "Blackout Rule" response was forwarded on September 18, 1990. Safety Evaluations relating to structural engineering, electrical distribution aspects, instrumentation/load sequencing, and auxiliary/support systems were forwarded on April 28, 1992.

Additional Safety Evaluations are enclosed, they are: (1) an electrical distribution supplemental safety evaluation, (2) a revision to the instrumentation/load sequencing safety evaluation, (3) a safety evaluation documenting the results of the load sequencer audit and (4) a safety evaluation for the mechanical design aspects.
