14. DESCRIPTION OF AMENDMENT/MODIFICATION (Organized by UCF section headings, including solicitation/contract subject matter where feasible.) The purpose of this modification is to formally recognize, in accordance with negotiations on April 23, 1985, the lease arrangement for the four (4) IBM personal computers. Accordingly, the subject contract is modified as follows:  The parties hereto mutually agree that leasing for the four (4) personal computers shall be on a month-to-month basis commencing on May 7, 1985 and ending August 7, 1985. At anytime during this period (May 7, 1985 through August 7, 1985) the Government may discontinue this arrangement by verbal or written notification to the contractor. The contractor shall be given at least a three (3) day notification.

The monthly lease price per computer is \$160. This price includes charges for the computer itself, printer, communication board, and monitor. The total monthly price for lease of all four (4) computers is \$640. Contingent upon continuity of this specific service by the Government, the price shall be prorated on a monthly basis. For example, if the service is required for only fifteen (15) days during a one month period, the price will be adjusted accordingly e.g., \$320. Funds to cover this specific service are set forth in Modification No. 14.

All other terms and conditions of this contract remain unchanged.
