Dear Mr. Lanoue:

This is in response to your letter of November 28, 1975, in which you requested, pursuant to the Freedom of Information Act, that the Monticello nuclear facility radiological emergency plans and any other related documents be made available to you. Your request was received on December 3 and has been referred to me.

As you requested, I am enclosing the Emergency Plans, Section 5.16 of the Monticello application for a full-term license dated June 15, 1972, and Section E.2 of Volume E of the Operation Manual which details the emergency procedures. These documents provided the basis for our acceptance of the Emergency Plan for the Monticello nuclear facility. A copy of the AEC "Safety Evaluation For Full-Term License Review Monticello Nuclear Plant Unit 1" dated February 5, 1973, is also enclosed for your information. Other miscellaneous related correspondence also are enclosed. In addition, other related documents are available in the Public Document Room, 1717 H Street, N. W., Washington, D. C. 20555.

We understand that the State of Minnesota is revising the State Radiological Emergency Response Plans which pertain to the Monticello plant and suggest that you contact the State for the latest documents.
