Dear Ms. Rapkin:

This is in response to your letter dated January 10, 1985, in which you requested, pursuant to the Freedom of Information Act (FOIA), all reports of inspection conducted by the Atomic Energy Commission and the Nuclear Regulatory Commission from 1954 until the present for the Rare Earths facility and intra-agency and inter-agency records concerning these inspection.

The enclosed Appendix A is a list of 202 documents related to your request. Copies of these documents are enclosed with this letter. The enclosed Appendix B is a list of reports also related to your request. These reports have previously been made available at the NRC's Public Document Room (PDR), 1717 H Street, NW, Washington, DC 20555. There is no charge for inspecting records maintained at the PDR. I am enclosing a copy of a notice that provides charges and procedures for obtaining copies of records from the PDR.

Documents 1 and 2 of enclosed Appendix C contain information which is being withheld pursuant to Exemption 5 of the FOIA (5 U.S.C. 552(b)(5)) and 10 CFR 9.5(a)(5) of the Commission's regulations. Document 1 is a two-page memorandum with a 29-page enclosure. The memorandum and enclosure were prepared by the agency's Region III office in response to the Office of the Executive Legal Director's (OELD) request that the Region review the inspection history to assist the agency in preparing for the upcoming hearing. Releasing the document would tend to inhibit the open and frank exchange of ideas essential to the deliberative process. The nonexempt portions of this document are enclosed.

Document 2 is an 18-page draft which was prepared by OELD specifically as an aid in organizing the hearing. This document also contains predecisional advice and recommendations of the staff. Releasing this document would tend to inhibit the open and frank exchange of ideas essential to the deliberative process. There are no reasonably segregable factual portions. Portions of the remaining documents listed on Appendix C are being withheld. The information being withheld consists of names, social security numbers, home addresses, and personal identifiers of certain individuals who may have had some radiation exposure, the disclosure of which would constitute a clearly unwarranted invasion of personal privacy. This information is being withheld from public disclosure pursuant to Exemption (6) of the FOIA (5 U.S.C. 552(b)(6)) and 10 CFR 9.5(a)(6) of the Commission's regulations.

Further, all documents which have previously been provided to you as a recipient of Region III's Standard Distribution List for Kerr-McGee Chemical Corporation's Rare Earths facility in West Chicago, Illinois, are not being provided to you again.

Also, as agreed in a February 7, 1985, telephone conversation with Nina Toms, all documents in the Office of Nuclear Material Safety and Safeguards will not be addressed under this FOIA request but dealt with separately under your discovery request. You advised Ms. Toms that you will review these documents at the NRC's Silver Spring office during your visit sometime around the middle of March.

Pursuant to 10 CFR 9.9 and 9.15 of the Commission's regulations, it has been determined that the information withheld is exempt from production or disclosure, and that its production or disclosure is contrary to the public interest. The persons responsible for the denied portions of documents three through seven of Appendix C are the undersigned and Mr. James G. Keppler, Regional Administrator, Region JII. The person responsible for the denial of documents one and two of Appendix C is Mr. Guy Cunningham, Executive Legal Director.

The denial by Mr. Keppler and myself may be appealed to the Executive Director for Operations within 30 days from the receipt of this letter. Any such appeal must be in writing, addressed to the Executive Director for Operations, U.S. Nuclear Regulatory Commission, Washington, DC 20555, and should clearly state on the envelope and in the letter that it is an "Appeal from an Initial FOIA Decision." The denial by Mr. Cunningham may be appealed within 30 days to the Commission and should be addressed to the Secretary of the Commission.

This completes NRC's action on your FOIA request.
