Compliance Inspection Report on Lindsay Chemical Division, American Potash and Chemical Corporation, West Chicago, Illinois, dated July 6, 1959, contained information taken from the licensee's records relating to export shipments of source materials.

Licenses S-5088A, S-5148D, S-5337B, and S-5380B authorizing export of source material were listed in the licensee's records. Copies of these licenses had not been received in this office.

A memo route slip from Miss Brady, dated September 23, 1959, indicated that no licenses had been issued for S-5088A, S-5148D, S-5337B, and S-5380B. Therefore, it appeared that the licensee may have made unauthorized exports of source material.

Mr. T. W. Brockett, Jr. visited the licensee on October 14, 1959. He interviewed Mr. J. K. Baker of the Sales Department and obtained information from the licensee's records relating to shipments of source material.
