Beaumont Michigan Heart Group, 4600 Investment Drive, Suite 200, Troy, MI 48098 is currently licensed by NRC (21-26392-01) for 10 CFR 35.100 and 10 CFR 35.200 (As needed). On June 1, 2012, Michigan Heart Group, P.C. entered into an agreement with Beaumont Health System to transfer control of this NRC License to Beaumont Health System with the name Beaumont Michigan Heart Group. Under this professional service agreement, and NRC approval (Amendment #10; July 19, 2012) Beaumont Health System assumed direct control of the activities and radioactive materials authorized under NRC License No. 21-26392-01.

5.1 Description of the Transaction

The professional service agreement between Michigan Heart Group, P.C. and Beaumont Health will expire on October 31, 2020. This agreement will not be renewed. We request written consent from the U.S. Nuclear Regulatory Commission for the direct change of control from Beaumont Health as Beaumont Michigan Heart Group back to Michigan Heart Group, PC. Effective November 1, 2020, Michigan Heart Group, PC will assume direct control of the activities and radioactive materials authorized under NRC License No. 21-26392-01 at both 4600 Investment Drive, Troy, Michigan 48098 and 39500 Ten Mile Road, Novi, Michigan 48375.

5.3 Changes in Location, Equipment and Procedures

The NRC licensed program at 4600 Investment Drive, Suite 200, Troy, Michigan and 39500 Ten Mile Road, Novi, Michigan will be managed and under direct control of Michigan Heart Group, PC. The

location of the nuclear cardiology department, including the equipment, facilities where radioactive materials are used and stored, will not change. No relevant equipment or procedural changes are expected at this time.

Documentation in accordance with NUREG-1556, Vol. 15, Section 5, will be provided under a separate cover within 30 days of the dissolution of the professional service agreement. This will include radiation safety surveillance records, any decommissioning and related transfer records, and documentation that both the transferee and transferor agree to the change in ownership.
