As a minimum, however, you are required to forward copies of all correspondence with contractors to the Contracting Officer. Prior Contracting Officer concurrence may be required for some correspondence and others may be forwarded to the contractor <u>only</u> over the Contracting Officer's signature. Mutual cooperation and agreement between the Project Officer and the Contracting Officer will be the key to these determinations.

Further, you are required to comply with the provisions of NRC Manual Chapter 5103 - NRC Review of Contractor Invoices. While this Manual Chapter and the NRC Form 292 included therein require your assessment of the contractor's overall performance in the review of submitted contractor invoices, it is suggested that any potential contractor problem be brought to the attention of the Contracting Officer as early as possible so that positive corrective action can be initiated.

The Contract Administrator responsible for the administration of the contract is Ms. Teresa McLearen. She should be advised in advance of <u>any</u> scheduled meetings with the contractor.
