SUMMARY

SCOPE:

This routine, unannounced inspection entailed a review of procedures, records, operations, and physical inventory for use, control and accountability of special nuclear material.

RESULTS:

One violation of regulatory requirements was identified during the inspection (Paragraph 2). The licensee failed to adequately secure and control access to SNM located in an unrestricted area. Access to SNM bearing items housed in a warehouse, located outside the facility protected area, was not secured in the manner required for protecting SNM.
