At your request by phone call Friday, September 20th, 1996, this is notification of the bankruptcy of Miller Associates, Engineers, Planners & Surveyors, Inc.. An Involuntary Petition was filed in this case.



**INVOLUNTARY PETITION UNDER CHAPTER 7**

1. Petitioner Boone County National Bank, a nationally chartered banking corporation with its principal offices at 720 East Broadway, Columbia, Missouri 65201, holds unsecured claims against the Debtor, not contingent as to liability, and not subject to a bona fide dispute, in excess of \$10,000.00.

2. Petitioner DEKA Geotechnical, 5425 Highway 763, Columbia, Missouri 65202, holds unsecured claims against the Debtor, not contingent as to liability, and not subject to a bona fide dispute, in excess of \$2,400.00.

3. Petitioner Quality Reprographics, 7546 Watson Road, St. Louis, MO 63119, holds unsecured claims against the Debtor, not contingent as to liability, and not subject to a bona fide dispute, in excess of \$1,000.00.

4. Petitioner Jody Crane, d/b/a Clean Queen, 1514 St. Christopher, Columbia, Missouri 65203, holds unsecured claims against the Debtor, not contingent as to liability, and not subject to a bona fide dispute, in excess of \$1,912.00.

5. Petitioner Columbia Office Supply, 1901 Vandiver Drive, Columbia, Missouri 65202, holds unsecured claims against the Debtor, not contingent as to liability, and not subject to a bona fide dispute, in excess of \$214.00.

6. Petitioners' claims stem from moneys owed by Debtor pursuant to promissory notes and security agreements or to contracts for supplies and services.

7. Upon information and belief, the Debtor's place of business and principal assets are located at 1390 Boone Industrial Drive, Columbia, Missouri, and have been within this district for more than 180 days preceding the filing of this Petition.

8. The Debtor is a person against whom an Order for Relief may be entered until Title 11, United States Bankruptcy Code.


9. The Debtor is generally not paying its debts as such debts become due.





**ORDER**

Now on this 16th day of May 1996, the Involuntary Petition filed herein by Boone County National Bank and others against Miller Associates, Engineers, Planners & Surveyors, Inc., comes on for hearing. The Court finds that the Involuntary Petition was filed in this Court on April 22, 1996, and that counsel for the Petitioners has served the Involuntary Petition and has given notice to the Debtor and its counsel of this hearing, as required by the Bankruptcy Rules, more than 20 days prior to this hearing. The Debtor has not filed any response in this Court and no one appears on behalf of the Debtor. Therefore, the Debtor is in default. On the basis of the pleadings and the statements of counsel for the Petitioners, the Court finds that the Debtor is insolvent as defined in the Bankruptcy Code and that it would be proper to adjudicate the Debtor bankrupt and enter an order for relief under Chapter 7 of the Bankruptcy Code. Therefore, it is

ORDERED that Miller Associates, Engineers, Planners & Surveyors, Inc., be and is hereby adjudicated bankrupt and an order for relief is entered pursuant to Chapter 7 of the Bankruptcy Code. Debtor is hereby directed to file its Chapter 7 schedules and statements of affairs within 15 days of the date of this Order. Counsel for Petitioners is hereby directed to serve a copy of this Order on the Debtor and Debtor's counsel by facsimile and by first class mail immediately.
